VETERAN EXEMPTION

House Bill 3613 proposes a constitutional amendment that allows the legislature to raise the current ad valorem tax exemption for disabled veteran's and their surviving spouses and minor children. The tax exemptions would be raised based on a veteran's disability rating as follows:

10% - But less than 30%	5,000
30% - But less than 50%	7,500
50% - But less than 70%	10,000
70% - And over	12,000
Age 65 and 10% or higher	12,000
Loss or loss of use of limb	12,000
Blindness or paraplegia	12,000

The spouse and children of any veteran who dies while on active duty may be granted an exemption of up to \$5,000. The amounts of the exemptions provided for in this proposed amendment may be repealed by the legislature by general law.
